d. <u>Authorization letter for transferring \$49,000 of funds from Blanca Flanagan Rios Revocable Trust to ELAC Foundation operating account #3751</u>

After consulting with MS. Mirjam Weber, from Payden & Rygel, who manages our accounts, we were informed that since 2014 the ELAC Foundation had awarded \$49 to 47 deserving ELAC students out of our general fund. No amount has ever been transferred out of this account. The only debits over the years were for paying the management fees. An authorization email was sent to Maura Thorpe, Co-Trustee for our Blanca Flanagan Rios Revocable Trust to transfer the funds to our main operating account.

Per vote by ELAC Budget Investment, Finance & Audit Committee August 18, 2021 Zoom Meeting Dr. Aghakhanian, Director of ELAC Foundation, has been ordered to send an authorization letter and email to Maura Thorpe, Co-Trustee for our Blanca Flanagan Rios Revocable Trust to transfer \$49,000 of the funds to our main operating account #3751.

e. Opening of three new endowment accounts with Preferred

Currently, all new endowments sit in the operating account, causing unnecessary accounting work. To remedy this, Dr. Armond Aghakhanian, ELAC Foundation Director, has opened three new Money Market Accounts with no service charges as long as the Balance is above \$2500 at Preferred Bank. The accounts # 2023164-The Jose Blas Sanchez scholarship, # 20223172-Richard & Cynthia Leza Hispanic Scholarship, and # 2023180- Gilbert Gerakos "Mayor of East LA.
