a. **ELAC Foundation Bylaws Amendment-** ELAC Foundation Director Dr. Armond Aghakhanian The ELACF Governance Committee voted unanimously during its October 18, 2023 meeting to recommend the following amendments to the ELACF bylaws by adding the following section to the ELACF Bylaws either in ARTICLE V Board of Directors Section 3 or to create a new Article to the ELACF bylaws:

The sole purpose of this Association is to seek, inspire, serve, and engage Alumni by providing environments and opportunities to engage and philanthropically support the next generation of leaders. The East Los Angeles College (ELAC) Alumni Association is recognized by the President of East Los Angeles College and the Foundation as the single campus-wide Alumni Association and under an auxiliary with privileges of such a status. The Association shall operate consistent with, Title 5 (Education), Article 15 (Alumni Associations) of the California Code of Regulations and under the California Nonprofit Public Benefit Corporation Law within the meaning of Internal Revenue Code CA 501 (c)(3) organization, Federal Tax ID# 33-0034221. The Association is made up of volunteers who provide field leadership, organize events, raise money, and promote and advance the interests of the Alumni.
